


# Annual Report 2017-2018

## **MESSAGE FROM THE EXECUTIVE DIRECTOR**

It has been two years since I've joined SEAWA. It has been a challenging couple of years but always productive, energetic, and rewarding. The previous year was about rebuilding the organization, reconnecting with stakeholders, listening to issues raised by stakeholders, and search for funding opportunities for collaborative stewardship projects. This year, in addition to the operational grant provided by Alberta Environment and Parks, SEAWA was fortunate to be a recipient of riparian restoration project funding. We have hired and trained new staff to enable project implementation. We have started project promotion, and recruitment of project partners for on-the-ground restoration work to start by April 2018. Riparian restoration in the SEAWA watershed involves the challenge of developing and applying practical methods that are appropriate to the semi-arid climate and ecology of the grassland natural region, and the local soil and landforms (coulees). Restoration methods should have the context of the irrigation infrastructure that has been integrated into the creek system (tributaries), and the predominant land use of irrigated agriculture, and cattle ranching. With the participation of landowners and volunteers, we look forward to a successful restoration of 20 km of riparian areas in the next couple of years.

Thank you for the leadership provided by the Chair, and for all the work done by the directors of the Board, members of Committees and by other volunteers and supporters of SEAWA.

# **ENHANCING ORGANIZATIONAL CAPACITY**

It was a year full of enthusiasm and energy. Key stakeholders were keen on seeing SEAWA provide leadership on practical watershed stewardship projects. Stewardship is one of the roles (Program Areas) of a Watershed Planning and Advisory Council (WPAC). The other roles are: watershed assessment, watershed management planning, and community engagement, education, and outreach.

SEAWA was awarded project funding for riparian areas assessment and restoration (riparian project). A multi-year grant (April 2017 to March 2020) was received from the Government of Alberta's Watershed Resiliency and Restoration Program (WRRP). The federal government's Recreational Fisheries Conservation Partnerships Program (RFCPP) funding for the same project is to be implemented within the period April 2018 to November 2018. Progress reports, plans and budget revisions were submitted to funders.

The aerial assessment of riparian areas in the Seven Persons Creek watershed was contracted out to a consulting firm. The project was to be completed in April 2018.

Recruitment of restoration partners was started and is ongoing. Additional information is accessible at www.seawa.ca, Projects page.

The water quality portion of the riparian project was funded through a donation from Plains Midstream Canada and Alberta Irrigation Projects Association.

New staff members were recruited to implement the project: Patrick Jablkowski, Watershed Coordinator, joined on June 16, 2017 and Natasha Rogers, Restoration Intern joined on March 16, 2018. The Restoration Intern wage was subsidized by United Nations Association—Canada.

Seline Solis joined on May 1, 2017 as a summer student and delivered SEAWA's summer outreach program. The summer student wage was subsidized by the Canada Summer Jobs program.

In addition to organizational and administrative tasks, the Executive Director, Marilou Montemayor, provided overall

project management, scientific/ technical expertise for the project, was primary author of educational materials, and guided the implementation of communications and outreach activities.

The Annual General Meeting was held on June 8, 2017. Ten new members joined the SEAWA board which brought the total to 16, out of the maximum 17. Stuart Murray, Chairperson stepped down and remained active as Past Chair on the Board, and the Executive and Technical Committees. Garry Lentz was elected as the new Chairperson. Bylaw, Mission Statement and other policy document amendments were approved. A new Employee Manual was approved.


The Fundraising and Human Resources Committees were combined with the Executive Committee for efficiency. The Technical Committee has been very active this year due to the start of the riparian project. The Communications Committee provided suggestions and guidance in the implementation of SEAWA's Communication Strategy as well as of the communication plan of the riparian project.

SEAWA's organizational structure was updated.

A Special Meeting of the membership was held on January 8, 2018 to approve bylaw amendments.

Operational documents were prepared and submitted to Alberta Environment & Parks as part of the operational grant application: Annual Operation Plan and Budget 2018 -2019 and an updated Communications Strategy 2017-2020. Grant 2016-2017 closure (June 30, 2017) and interim 2017-2018 (October 17, 2017) reports were submitted.

SEAWA is looking forward to an increase in funding and/or donations to enhance staff capacity as well as to implement watershed studies, and educational and stewardship projects. SEAWA is also working towards increase in volunteer participation on the board and committees, and stewardship initiatives.



# **IN-KIND CONTRIBUTION**

SEAWA is financially supported by a cash grant from Alberta Environment and Parks (AEP), and contributions from federal government programs, other organizations and individuals. However, volunteer services (valued as in-kind contribution) form the backbone of SEAWA as a fully functional WPAC, through its Board and Committees, partners and individuals. In-kind contribution was determined based on services provided (board and committees—\$80/hr, labour—\$25/hr, students—\$18/hr); and non-reimbursed travel expenses incurred (\$0.505/km, accommodation, and meals) by SEAWA volunteers. The total in-kind contribution of volunteers for the fiscal year under report was **\$78,447**. The total in-kind contribution from AEP staff was \$3,600.



## **TREASURER'S REPORT**

Alberta Environment and Parks funded SEAWA's core operations, and community engagement activities with \$250,000 for 2017-2018. Project funding of \$221,000 (April 2017 to March 2020) was received through the Government of Alberta's Watershed Resiliency and Restoration Program. Additional contributions came from the Canada Summer Jobs Program, Alberta Irrigation Projects Association, Plains Midstream Canada, and other individual donors. SEAWA maintains a reserve fund that was raised from donations in the prior years (2012-2013, 2013-2014, 2014-2015).

## WATERSHED STUDIES, PLANNING & STEWARDSHIP

SEAWA's work is guided by *Water for Life—Alberta's Strategy for Sustainability*; the *South Saskatchewan Regional Plan (SSRP)*; WPAC Program Areas as prescribed by AEP; and SEAWA's Vision, Mission, and Strategic Goals. In addition, stakeholders bring forth ideas and suggestions that are considered in accordance with these guiding policies. With the release of the SSRP, SEAWA has moved from information gathering for state of the watershed reporting, and watershed management planning, to the implementation phase of the regional plan.

Restoration project activities were started:

- Riparian Areas Assessment of the Seven Persons Creek Watershed—contracted out to Stantec
- Restoration partner recruitment presentations to and conversations with landowners and land managers
- Preparation of landowner application for funding

process and related documents

- Preparation of restoration plans for potential restoration sites
- Project Promotion (brochures distributed at events, post cards mailed-out, advertisement in local newspapers, newsletter, and social media) and Information Sessions (a forum and an open house)
- An applied research plan was finalized Educational materials were produced:
- Booklet—Riparian Areas and Riparian Plants in the Seven Persons Creek Watershed
- Info-sheet—Recognizing Riparian Ecological Services
- Info-sheet—Understanding Water Quality in the Seven Persons Creek Watershed

## **STRENGTHENING RELATIONSHIPS & BUILDING NETWORKS**

Collaborative programs and projects, and support to fund these initiatives need relationship building, networking, that enable the creation of partnerships. Cooperation between governments and NGOs within the greater South Saskatchewan Region, the Prairie Region, and the Saskatchewan River Basin (upstream and downstream watersheds) is also necessary for a watershed-scale management approach to environmental issues. Therefore, SEAWA participates in activities that build, renew, and strengthen relationships; and forms partnerships among the core and extended networks that share a common interest in water and watershed management. These activities help SEAWA achieve its goals and further the recognition of SEAWA as a relevant and useful organization to stakeholders.

SEAWA staff, Directors of the Board, committees, members, and stakeholders participated in several activities throughout the year:

**Conversations** about potential collaborative riparian projects with: University of Alberta, City of Medicine Hat, St. Mary River Irrigation District (SMRID), County of Warner, County of Forty Mile, and private landowners.

Feedback provided: AEP Review of WPAC roles

**Public consultation**—Alberta Energy Regulator public consultation at Medicine Hat—Shaping Future Conversations, and Town of Redcliff Municipal Development Plan.

**Conferences and Workshops:** attended Climate Change and the Future of Energy, Mixed Grass Forum, Medicine Hat; and Alberta Ecotrust Environmental Gathering, Calgary. Presented at Farming Smarter Conference, Medicine Hat.

**Network Meetings** attended: Intra-Basin Water Coordinating Committee meeting, and provided feedback on committee Terms of Reference; South Saskatchewan River Basin Water Management Plan 2006 review project, WPAC Managers and Coordinators meetings, AEP and South Saskatchewan Region WPACs meeting, SMRID meeting on riparian areas project at Sauder reservoir, AEP -WPAC Forum, Edmonton; Environmental Land Reclamation Program Advisory Committee, Medicine Hat College; Water Channel portal; and presented at the County of Forty Mile Agricultural Services Board meeting.

**Partnerships**: Formalized partnership with Praxis Society, Medicine Hat. Partnership with Grasslands Naturalists is activity or project specific.

**Surveys**—responded to: Ministry of Labour Wage and Salary survey, and Alberta Energy Regulator survey.

**Events**—Presented at the Annual General Meeting of the Grasslands Naturalists Medicine Hat, and participated with their wildflower walk; staff participated with the Commuter Challenge on Environment Week.

**Visit**—Minister Shaye Anderson, and Speaker of the House, Legislative Assembly, Hon. Robert Wanner visited SEAWA.

**WPAC Summit preparations**—prepared an article on SEAWA's 2017 (calendar year) accomplishments for the WPAC Summit 2018 booklet.

#### **SHARING KNOWLEDGE & OUTREACH**

**Educational Forum:** Riparian Areas and Project Information Event, November 2, 2017, Medicine Hat.

**School and community outreach:** The summer student educated school children (Grades 2, 4, 5, and 8) about watersheds with demonstrations of the non-point source pollution watershed model and the wetland model. This Activities covered 5 schools, and a total of 362 children. In These activities were also delivered to three summer camps with a total of 111 children. Praxis Society, Medicine Hat, helped in the delivery of these activities. SEAWA staff volunteered as judges at the science fair of two schools.

**SEAWA at community events** in Medicine Hat: Canada Day, Stampede (Summer festival), World Water Day at the Medicine Hat Public Library, Vital Signs report, and spring clean-up organized by the city of Medicine hat.

**Newsletters**: sent out every two months: May, July, September, November 2017; and January, March 2018; they are posted on the SEAWA website, Resources page.

A new **SEAWA Brochure** was finalized and distributed at SEAWA and community events.

Social media interaction is ongoing—Facebook (Seawa Watershed) has 300 friends, and twitter (@SEAlbertawaters) has 1,900 followers.

**Community organizations**— membership with Medicine Hat Horticultural Society, Community Garden, and Grasslands Naturalists.

# **MOVING AHEAD**

SEAWA is focussed next year on the completion of the aerial riparian areas assessment of the Seven Persons Creek Watershed, on-the-ground riparian restoration work, and further recruitment of partners to participate in the project. Towards the fall season, SEAWA will look for project grant opportunities that will help address issues identified or raised by its stakeholder.

## **STRATEGIC GOALS 2017-2020**

- Goal 1 SEAWA has sustainable funding, and improved administrative and organization capacity.
- **Goal 2** Resources are generated or acquired, the SEAWA watershed is assessed, and watershed knowledge is developed.
- Goal 3 Watershed management plans are developed.
- **Goal 4** Stakeholder engagement, and partnerships and networks, are strengthened or enhanced, and education and outreach activities are implemented.
- **Goal 5** Resources are generated or acquired, and environmental stewardship projects or initiatives are implemented.
- **Goal 6** SEAWA's role in the implementation of the South Saskatchewan Regional Plan (SSRP) is established.

Based on the six Strategic Goals above, SEAWA's key activities for the upcoming year are:

Goal 1: Volunteer recruitment for riparian restoration work, charitable status application, continued policy development and update, and performance evaluation of the organization;

Goal 2: Year 2 implementation of the project, *Riparian Areas Assessment and Restoration in the Seven Persons Creek Watershed,* which includes the aerial assessment of riparian areas; and an applied research related to riparian restoration;

Goal 3: None in 2018-2019; (source water protection planning is being proposed for the following year);

Goal 4: Ongoing implementation of the Communication Strategy—stakeholder engagement, partnerships, networking, education, and outreach;

Goal 5: Year 2 implementation of the project, *Riparian Areas Assessment and Restoration in the Seven Persons Creek Watershed*, which includes preparation of restoration plans with each project partner, partnership agreements, and on-the-ground restoration work;

Goal 6: Implementation of some of the SSRP recommendations (Goals 2 and 5) and continued conversation/feedback on and topics of water and watersheds, land, air, and biodiversity as they arise.
